

## TERMS & CONDITIONS

Please read following terms & conditions (hereinafter referred to as "Terms and Conditions") carefully. By purchasing an admission ticket drivers and any persons traveling in the vehicle are accepting these terms.

### GENERAL

1. Only customers in possession of a valid ticket will be admitted into the auditorium to which the ticket relates and admission will be permitted only for the duration of the performance specified by the ticket.
2. Please keep your tickets for inspection until you leave the premises.
4. The ticket fee is 50 PLN per vehicle, regardless of the number of persons traveling in the vehicle.
5. Only passenger cars will be admitted into the drive-in cinema "Syreni Brzeg".
6. The maximum number of persons in the car entering the drive-in cinema "Syreni Brzeg" is determined by the regulations of the Ministry of Health and the Ministry of Culture and National Heritage in Poland. Only half of the seats in the vehicle may be occupied at the date of entry into force of the Terms. In the event that more than half of the seats in the vehicle is occupied, such vehicle shall not be admitted into the drive-in cinema "Syreni Brzeg".
7. Persons on bicycles, motorcycles, mopeds, electric scooters, buses, trucks, shall not be not admitted into the cinema. Persons traveling in semi-convertible vehicles must cover their mouths and nose throughout their stay on site.
8. Before the feature film starts, ads and trailers will be shown. The duration of ads and movie trailers before each film will be determined by the owner of the drive-in cinema.
9. Lost, stolen or damaged tickets are not exchangeable. Persons without a valid ticket will not be admitted into the cinema. Persons not possessing the ticket at the time of inspection may be asked to leave the premises.
10. Car parking spaces will not be reserved for either online booking or tickets purchased at the entrance. The customer is obliged to follow the instructions of parking stewards and cinema staff. Vehicles that are in excess of 1,5 high from the ground to the top of the car, such as SUVs, VANS may be requested to park towards the back half of the venue away from the screen.
11. Tickets to the drive-in cinema "Syreni Brzeg" can be purchased online or at the cash desk. Online tickets can be purchased up to 60 minutes before the show on a given day. The cash desk is open 90 minutes before the show on a given day. We accept cash and card payments, however card payments are preferred.
12. The drive-in cinema reserves the right to refuse the entry onto its premises of any person who is believed to be intoxicated, possess dangerous objects or their conduct may threaten the safety of others. All vehicle occupants must be eligible for the appropriate film rating or be accompanied by their legal guardians. The drive-in cinema may refuse the entry onto its premises also in the case of circumstances beyond the control of the organizer.
13. The Organizer reserves the right to cancel a film screening. Cancellation may occur as a result of: national mourning, the occurrence of force majeure or weather conditions threatening the safety of the participants of the show.

14. Rainy weather shall not be regarded as conditions which endanger the safety of the participants in the show. Only the cinema manager can decide whether to cancel the show.

15. The ticket for the show is non-refundable except for the cancellation of the event for reasons attributable to the organizer. If the organizer has indicated a new date for a given cultural event, it is possible to use the ticket within that period. The cinema manager may decide to refund the amount paid for the ticket to customers according to their request.

16. The cash desk opens 90 minutes before the first screening or cultural event scheduled on a given day, and closes 5 minutes before the start of the last screening or cultural event scheduled for the day.

17. The drive-in cinema "Syreni Brzeg" reserves the right to cancel or change the time of the screening of the film or replace it with another film.

18. "Syreni Brzeg" is not responsible for errors in the repertoire published in the printed press or on other websites.

19. Please do not disturb other viewers during the screening by using mobile phones, loud conversations, or any other behavior.

20. The organizer reserves the right to remove from the premises persons violating these Terms and Conditions or safety rules of the cinema.

21. The cinema customers are asked to report to the staff any situation that may cause a violation of order or threaten safety.

22. The drive-in cinema "Syreni Brzeg" is not responsible for any information displayed or broadcasted on the premises of the cinema by any third parties.

23. Please report to the cinema staff poor video or sound quality of the film displayed during the screening or immediately after the screening. Please note that failure to do so may result in the absence of any subsequent possibility of confirming the validity of the objections made and thus taking into account complaints from clients.

24. The cinema staff is ready to provide additional information and assistance in resolving any problems and possible disputes or issues not regulated by these Terms and Conditions.

25. The cinema customers are asked not to leave their belongings unattended. The organizer shall assume no responsibility for any loss, theft or damage of customers property.

26. The cinema customers must have their mouths and nose covered when they open the windows in their vehicles.

27. During a film screening it is prohibited:

a) to record any image and sound - in accordance with the Act of 4 February 1994 on copyright and related rights (Journal of Laws of 1994). U. of 2006 No. 90, item 631 as amended), we remind customers that copying or attempting to copy any film, soundtrack or other copyrighted material presented in the cinema and its further distribution constitutes a serious crime. If a cinema employee records the use of imaging or sound recording equipment and there is a reasonable suspicion of illegal copying of film material by persons present in the cinema, the cinema employee is obliged to remove that person from the cinema premises together with the other passengers of the vehicle.

(b) aggressive and loud behavior, disrupting the perception of the displayed film,

- (c) smoking cigarettes and e-cigarettes,
- (d) bringing animals into the cinema premises.
- (e) possession of firearms and explosives or other objects endangering the safety of other viewers
- (f) leaving the car
- (g) staying on the beach area located in the cinema premises
- (h) approaching the pond located in the cinema premises

#### **CAR TRAFFIC ON THE PREMISES OF CINEMA**

- One-way traffic
- Drivers shall follow the instructions of the cinema staff
- The maximum speed in the cinema area is 10 km/h
- It is prohibited to drive with the handbrake on

#### **FINAL PROVISIONS**

1. The organizer of the drive-in cinema "Syreni Brzeg" is Madam Events Joanna Mazurkiewicz with its registered office in Warsaw on Urszula Ledóchowska 5H lok. 18 Street, (02-972, Warsaw) entered in the Central Register of Economic Activity Tax ID: 1132190311 REGON: 381933699
2. Cinema screenings are not a mass event within the meaning of the Act of 20 March, 2009 on the safety of mass events.
3. These Terms and Conditions shall enter into force on May 26, 2020.
4. Customers shall read these Terms and Conditions before purchasing ticket.
5. By entering the cinema premises the customer accepts the Terms and Conditions.
6. In the event of a breach by the customer or a group of customers of any provision of these Terms and Conditions, in addition to other rights, the organizer shall reserve the right to take all measures to obtain reimbursement of any costs incurred and to pursue any damages in court.
7. In the event of any accident in the cinema premises, the cinema staff must be notified without delay, allowing immediate assistance to the injured persons and ensuring the safety of other guests.
